A Coordinator will be on-call to accept client calls, referrals, and to coordinate services in an emergency



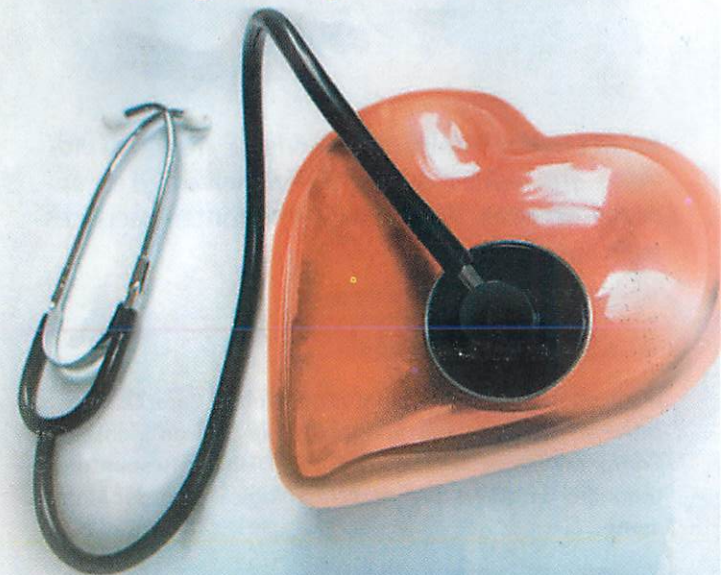

## Who is eligible ?

To qualify for services from MCM Loving Healthcare, a patient must :

- Be essentially homebound. The patient need not be bedridden and must require assistance to leave home.
- Needs intermittent care. The agency cannot provide full-time care, but can arrange for the care of training, of family members or other caregivers.
- Required skilled medical care by a health care professional



Skilled Nursing will be available 7 days week. We can arrange medical equipment ( wheel-chairs, walkers, canes, hospital beds, etc.) and prescribed medication delivered for free. Laboratory and diagnostic services such as portable digital X Ray, ultrasound and EKG services can be arranged as well. Medical Doctor, Dietitians and Podiatrists are also available to do house calls per request.
